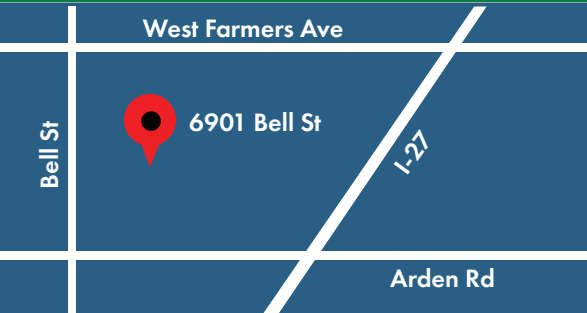

The petition must be signed by a minimum of 1% of members eligible to vote as of year-end 2024. The petition must be submitted to the nominating committee by February 21st, 2025 (40 Days prior to the annual meeting). If only one member is nominated for each position to be filled, a voice vote may be taken, or the Chairman of Board or CEO may declare each nominee elected by general consent or acclamation at the Annual Meeting. There will be no nominations from the floor.
